3. that the Institution shall adopt the curriculum and syllabus prescribed by Government from time to time
4. that the school timings, vacations and mid-term holidays shall be as prescribed by Government from time to time.
5. that the Qualified staff within the age limits prescribed by the Government Employees shall be appointed as per the staff pattern.
6. that the results of Institution shall be satisfactory every year.
7. that the records accounts shall be furnished to the District Educational Officer every year by 30th September at least.
8. that the list of Governing Body shall be furnished to the District Educational Officer every year.
9. that the Pay structure or Fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.

10. that all the conditions prescribed in the G.Os and other orders which are not specified in this order shall be complied with.
11. that the school shall not be closed without giving notice both to the parents, District Educational Officer and competent authority at least six months before.
12. that the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
13. that the society shall submit proposals for Provisional or Renewal of Recognition sufficiently in advance (i.e.) at least six months prior to the date of the present recognition.
14. All the appointments should be regulated as per norms stipulated in G.O.Ms.No:1 Education, dated: 01-01-1994.
15. Other conditions as per GOMS No: 1 Education, dated: 01-01-1994, G.o.Ms.No.41 Education, dated 11-05-2006. and G.O.Ms.No.74 Edn., dated 11-09-2006 should be followed from time to time.
16. Structural soundness and sanitary certificates issued by the competent authority should be produced every year
17. No Objection Certificate issued by the District Fire Officer should be submitted every year.

The Correspondent is hereby informed that the undersigned has vested powers to withdraw the recognition now accorded, if there is any deviation or false information or non-fulfillment of conditions as per rules in force without any notice in future.

The Correspondent has submitted the application for Provisional Recognition for the classes VIII to X under (EM) in the school for the years from 2020-2021 to 2022-2023 through the Deputy Educational Officer, Rajahmahendravaram in the reference 7th cited. The District Educational Officer, East Godavari, Kakinada has verified the application for Provisional Recognition with reference to the Inspection Report of the Inspecting Officer and as per the G.O.Ms.No.1 Education, Dated.01.01.1994 in the reference 8th cited.

As per the instructions of the Director of School Education, AP, Amaravati vide ref. 6th cited and under Rule 3(2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada, competent authority for Secondary Schools hereby grants **Provisional Recognition** for a period of **03 (THREE)** years i.e., for the academic years from **2020-2021 to 2022-2023** for the classes VIII to X under (EM) as recommended by the Deputy Educational Officer, Rajahmahendravaram and the District Educational Officer, East Godavari, Kakinada, subject to fulfillment of the following conditions in **Delhi Public School Rajahmundry, D.No.2-417, NH-16, Diwancheruvu, Rajanagaram (M), East Godavari District.**

1. That the society shall abide by the instructions / rules and regulations made by the Government or authorized Officer from the time to time.
2. That the Educational Institutions shall serve the needs of the locality more particularly.
3. The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
4. That the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
5. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
6. That the results of institution shall be satisfactory every year.
7. That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
8. That the list of Governing Body shall be furnished to the District Educational Officer every year.
9. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.
11. That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
12. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
13. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expiry of the present recognition.
14. That the society shall provide fire safety measures in the school as per the No Objection Certificate.
15. The management informed that no thatched roof accommodation is allowed to run the School.
16. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students.
17. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
18. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
19. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
20. The school shall have first aid kit and the teachers shall be trained in first aid.
21. The Correspondent of the concerned school is hereby informed to file an affidavit to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
22. That the management shall obtain and submit the structural soundness certificate and sanitary certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail.
23. That the management shall ensure the Accountants of this school audited by an authorized Chartered Accountant every year and submit.
24. That the management has to maintain trained teachers at all time.
25. The management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated.06.08.2009 regarding Fee Structure in Private Schools.
26. Further, the management is informed to follow the rules and regulations prescribed in Cir. Memo.No.21748/D1/97, dt.16-2-1998 and other orders of Transport Authority regarding parking of school vehicles / maintenance of vehicles and ensure safety of children, and shall obtain fitness of the school vehicles from the Transport Authorities as prescribed by the Government from time to time.
27. That the Management of the school is informed to obtain the renewal occupancy clearance from the Fire Services department concerned for the entire period of recognition now accorded from time to time and submit the same through the Inspecting Officer concerned to this office without fail.
28. That the Management of the school is informed that the recognition now accorded is subject to genuineness of the Fire NOC issued by the Fire Services Department.

If the management fails to comply with the above conditions promptly, the Recognition now granted will be reviewed. Receipt of these proceedings should be acknowledged.
